Past Department Commander Kerwin "Pee Wee" Douthit Passes Away

It is with sincere sorrow that Headquarters reports Past Department Commander Kerwin "Pee Wee" Douthit has reported to Post Everlasting.

Kerwin 'Pee Wee' Phoenix Douthit, 80, of Hot Springs, SD, passed away March 13, 2020, at Monument Health Rapid City Hospital in Rapid City, SD. Pee Wee was born June 23, 1939, in Vetal, SD, to

Pee Wee was born June 23, 1939, in Vetal, SD, to Frank and Dortha (Peterson) Douthit. He married his wife, Sereta, on October 19,1963.

Pee Wee proudly retired from the U.S. Air Force, serving from 1960 until his honorable discharge in 1982. He served in Vietnam, and his incredible story can be found in the book, "Vietnam Vets: Still Coming Home." I

Pee Wee joined the American Legion in 1963, and was a Paid Up For Life Member of Post #71 in Hot Springs, SD. He held several positions in his post before becoming District Commander in 1990-1992, followed by State Vice Commander in 1992-1993, and Department Commander in 1994-1995. Pee Wee's slogan during his command year was "Aim High in '95," a tribute to his Air Force days and his Legion goals. He was a vociferous opponent to flag desecration, and put adherence to the flag code and Americanism as top priority during his year. In a nod to what his future held, Pee Wee also encouraged Legionnaires to reach out to hospitalized vets: stop by and say, "Howdy."

thit Ever the steadfast servant, Pee Wee stayed active in the American Legion after his term as Commander, serving on the National Cemetery Committee from 1996-2006, and the VAVS committee from 2003-2020. While on the VAVS committee, Pee Wee stepped up to be the Hot Springs Hospital Representative, a position he held from 2003 until his passing.

Known for his sense of humor and friendly demeanor, Pee Wee was often found in the halls of the Hot Springs VA facility. He truly cared about the well-being of the patients in Hot Springs. In 2017, when VAVS funds were accidentally deposited into a wrong account, Pee Wee was "suspected" of taking his own money and buying stamps for his veterans.

Dedication to the American Legion defined Pee Wee and his wife, Sereta, who served as Department President from 1999-2000. We are forever grateful for the countless hours spent serving his fellow veteran. Godspeed, Pee Wee.

Pee Wee is survived by his wife, Sereta of Hot Springs; son, Jack of Hot Springs; daughter, Susan Douthit of Roseburg, OR; brother, Pete (Carolyn) Douthit of Louisiana; half sister, Donna Lamont of Martin, SD; grandchildren, Jake Hupp; John Hupp; Jacklyn Hawkins; Brooke Douthit; Jay Douthit; great grandchildren, Jaxon Hupp; Justice Hupp, Makayla Hawkins and a host of friends.

COVID-19 Pandemic Delivers Discord in Department Calendar

With the uncertainties we all are experiencing, Department Headquarters is asking American Legion family members to remain flexible as the leadership makes decisions to mitigate risks to our members and those who participate in our programs.

The South Dakota American Legion Department Executive Committee has made the following decision: "That all District Spring Conventions are postponed and rescheduled before the beginning of the 2020 State Convention, with meeting times to be determined. District Commanders may opt to conduct a meeting within their District before the Department Convention with the Department Commander's approval and if the current COVID-19 dangers have subsided. They must inform their Posts at least 15 days before such a meeting."

Additionally, the DEC has provided guidance for Post Elections: "The DEC recommends to the Posts to postpone their elections initially and to recommend to them to find other means to hold election of officers. Depending on their Constitution and Bylaws or if environmentally safe to gather in groups

This is a four-part article for me.

PART 1: I write this as we are in the middle of making decisions regarding spring meetings, state convention, Boys State and Legion Baseball. The COVID-19 Virus is of concern for our members and the youth who attend our programs. We do not want to add to the spread of this virus to our members / friends / family who do have health concerns.

Spring meetings have all been postponed so we can better assess the "social isolation" needed to slow the spread of the virus. Patience is requested from members as we put together a plan to mitigate risks for our members and still abide by the requirements in our Constitution and Bylaws. I would speculate there will be more changes in the coming weeks/months that will impact us. Please watch the Up To Now, e-mails and our Facebook account for updates.

We are adding an e-mail service to communicate with all of our members through MailChimp. Currently we have around 8,000 members with e-mail addresses in the MyLegion.org system. This is almost 50% of our members. We are requesting that Posts make an effort to enter e-mail addresses for members into the MyLegion website for the members who have and do use e-mail. We respect those members who do not use computers and also do not want to learn them, do not push your members to get an e -mail simply to put into the website, they will not use it if you force them.

I need your help spreading the word to members so they know they can sign up for our Legion News and Up To Now. We have around 360 members signed up for the Legion News and 790 signed up for the Up To Now. Out of 18,500+ members in South Dakota, only 2% receive the Legion news and only ½ of them open it up and read it. Our membership is not receiving information of the activities and events for the District and State level. We know we have part of our membership who still depend on traditional methods of communication. The Up To Now and Legion news are still be produced and mailed out to Posts.

We are currently looking at alternative ways to fund these mailings and we have a goal of achieving this in the near future. Expect more info to come

out in the Up To Now in the coming months.

For members to sign up for the Legion News or the Up To Now they can do so on the website for the South Dakota American Legion by going to this page: https://www.sdlegion.org/request-emailed-newsletters/ or you can put their information in for them and you can sign them up.

PART 3: The Dept. of South Dakota is moving to a new fundraising company. Mailings from the Department will be reduced down to four events during the year. Sweepstakes for MidWinter and State Convention along with labels in the Spring and Holiday season. All fundraisers will have the new South Dakota American Legion emblem on them, and the return address will be to Watertown, South Dakota. Rest assured that the monies donated to this will stay in South Dakota and go towards funding our programs.

PART 4: For those who have not heard, I have chosen to leave this position as State Adjutant. I want to ensure to you that I am not moving away from the South Dakota American Legion family; my decision is so I can focus on my family. I plan on staying active in our American Legion family. The service we provide to support our communities, veterans and youth is an asset that has far more reach than most of us realize. We impact the youth of our Nation through our Boys State and Baseball programs. Our programs teach them teamwork, government and give them a sense of pride in our Nation. The impact of our organization is why I am proud to be part of the American Legion family here in my home state of South Dakota. I'll see

Indianapolis-The coronavirus (COVID-19) pandemic continues to pose serious health risks, creating unprecedented responses from government and public health authorities and levels of uncertainty throughout the nation. The way in which it may spread, and its duration, cannot be accurately predicted. Because of these uncertainties, the 75th session of American Legion Boys Nation (scheduled for July 17-25 in Washington, D.C.) and the American Legion Junior Shooting 3-Position Air Rifle National Championship (scheduled for July 21-26 in Colorado Springs, Colo.) have been canceled. Already cancelled was the National Oratory Competition.

American Legion National Commander James W. "Bill" Oxford said the decision to cancel the 2020 Boys Nation program and air rifle national tournament "was difficult. It was made with safety as the highest priority."

Oxford hopes that this early cancellation notification will provide departments flexibility to make the best decisions possible for their respective Boys State programs, and provide shooting coaches flexibility for making the best decisions possible for their youth who are currently involved in the national postal tournament, "without feeling the pressure of their youth being excluded from the national capstone programs," he said.

Assessment is underway regarding the awarding of 2020 Samsung American Legion Scholarships to Boys State and Girls State participants. More information will be announced.

"Times right now are tough, but we will get through them together,' Oxford said. "Thank you for your patience, resilience and continued service to our great organization and country.'

If you are healthy, try to stay in touch with other members to find out if you can help them in any way. If you need help, reach out and ask for it. Once this all passes, we will still have a lot of things happening that will need your help. I'm specifically referring to Boys State and Youth Trooper Academy 2020. Hopefully these excellent programs will not be delayed or cancelled. I strongly suspect that the dates for registration will be extended.

At the February 2020 Midwinter Conference I provided a "game plan" for recruiting for our "Big 3" programs – Oratorical/Boys State/Youth Trooper Academy. Following is a synopsis of that briefing:
Using the "Big 3" Handout (see the handout at https://www.sdlegion.org/wp-content/uploads/2019/10/Americanism-Big-3-7-19-ADJ-COLORS.pdf) You should make b/w copies of this one page document and take them to the school to hand out to those attending.

Where to use the "Big 3":

Schools – Who to talk to about getting in to address the students

Principals

Counselors Debate Coaches

History/Civics/English Teachers

Honor Society Counselors

Anyone who will let you in!!!

Parent Teacher Organizations - PTA

Gives you the opportunity to talk directly to parents. Explain how our programs will help their children.

Community Groups

Scout Troops – Area councils (address the Scout Leader)

4-H Groups

Home School Associations/Groups

How to talk to Students/Parents

Schools – Make sure the students understand who we are and why we offer these programs.

Largest Veterans Organization in the world – All of us have spent time in the military and defended our country. We believe in working within our communities to pass on our values = reference our 4 Pillars. Explain what your Post does for your community – Baseball, support to youth programs, support local

Explain what exactly "Americanism" is and why we want them to learn it.

Oratorical Contest - Learn the constitution

Boys State – Learn about Local, County, and State Government - Their rights and obligations as a

Youth Trooper Academy – Talk about how we support 1st responders and how we offer the opport unity to train directly with SD Troopers if they have an interest in Law Enforcement at any level.

Tell parents about the scholarships we offer. They understand that higher education will be very expen sive and will be interested in how the money we offer can help.

Explain the opportunities to take part in the leadership training/practice offered by BS and YTA

Explain the public speaking opportunities we offer to improve their son or daughters debate skills. Community Groups

Scout Troops – Area councils (address the Scout Leaders):

Explain to them how their Eagle Scout candidates can use the opportunities available at Boys State and Youth Trooper Academy to earn their citizenship badges.

Boys State = The opportunity to interview their U.S. Senators, Congressman, Governor, State Reps, etc. 4-H Groups – Leadership opportunities

The opportunity to meet their political representatives and talk to them about impacts on Agriculture. Home School Associations/Groups

All "Big 3" programs offer Home Schooled individuals the opportunity to get out into their communities. Oratorical contest: Opportunity to speak publicly and compete with others for scholarships.

Boys State and Youth Trooper: Opportunity to interact with other students with similar interests.

How to "seal the deal"

Oratorical Scholarships: – Show them the numbers!!

Consider offering a small scholarship to the winner of your local Post (example: \$100) Find out if the District offers an additional amount at their level (example \$200)

Tell them about the scholarships offered if they win at the state level: (1st place winner \$1,000; 2nd place winner \$500; 3rd place winner \$300; and \$100 to the other contestants)

Scholarships offered if they make it to National contest: (\$2,000 for first and second rounds, \$20,000 for 1st place; \$17,000 for 2nd place; and \$15,000 for 3rd place).

Total winnings for someone who makes it to national finals and wins - Over 22,000 total!!

Establish a Post level scholarship for your attendees to compete for. Base it on your own standards (e.g. most outstanding performance at Boys State, etc.).

Mention the Samsung scholarship they can apply for during the application process. A 2019 SD attendee received a full \$10,000 scholarship.

Attendance makes them competitive for University/Trade School acceptance and additional scholarships. Gives them points toward application to Military Academies. At least one of the 2019 attendees received an appointment to the U.S. Military Academy.

Youth Trooper Academy:
Offer a small scholarship to the candidate from your local Post.

Let them know that the Academy offers a \$500 scholarship.

Department of SD offers another \$500 scholarship.

Outstanding participants are often offered the opportunity to enter the Trooper academy once they graduate from school. This is an opportunity to get a "shoe in the door".

I hope this information gives everyone the ideas/guidance they need to help their Post representatives get out into

Greetings Legionnaires

What a crazy few weeks its been. I know it's difficult to stay still, but hope that you've reignited a few hobbies to help keep your sanity during this self-induced social distancing. I've been taking walks at my local state park, learning how to homeschool (yikes—and we don't pay teachers enough), and trying not to hug people when I see them. These are dark times for natural huggers...the struggle is real.

Today, I'd like to address my Guard and Reserve Veterans...for too many years, you've been told that you are not eligible for VA benefits. Like with everything VA, times change, policies change. For example, updates to the M-21-1, the VA's Compensation and Pension Manual, are fairly constant. I'd like to highlight one important recent change right now:

M21-1. III.iv.4.D.1.c Considering National Guard and Reserve Duty for Hearing Loss and/or Tinnitus Claims Claims for Service Connection (SC) of hearing loss and/or tinnitus due to service in the National Guard or Reserves should be considered under the same criteria as any claim for SC of hearing loss and tinnitus. The condition must be regularly related to corrige.

- First, consider SC on the basis of potential relationship to periods of Active Duty or Active Duty for Training (ADT)
- When SC for hearing loss and/or tinnitus may not be directly related to a period of active duty or extended ADT, entitlement for SC may still be established if there has been a decrease in auditory acuity due to military duties as a member of the National Guard or Reserves.
- SC for hearing loss and/or tinnitus can be established for inactive duty for training (IADT) if the condition can be linked to an injury during IADT as shown by the nature of service, MOS, lay evidence, or other competent evidence.

NOTE: For purposes of hearing loss or tinnitus during Inactive Duty for Training, the MOS or other evidence establishing noise exposure serves as the injury during IADT required for SC eligibility.

The note is important. While the VA has been conceding noise exposure for most, if not all, active duty fields, inactive duty training uses the MOS to serve as the injury. To view a list of MOS noise exposure, please visit https://sdvsoa.weebly.com/helpful-links.html and search for the Duty MOS Noise Exposure link. This list isn't the end-all/be -all, as I'll note below with other common military noise exposures, but it does strengthen your argument that your National Guard or Reserves time lead to your hearing loss.

So, how can a job serve as an injury? I'm glad you asked. First, a glimpse into how hearing loss occurs: According to the CDC, hearing loss can result from a single loud sound (like firecrackers) near your ear. Or, more often, hearing loss can result over time from damage caused by repeated exposures to loud sounds. The louder the sound, the shorter the amount of time it takes for hearing loss to occur. The longer the exposure, the greater the risk for hearing loss (especially when hearing protection is not used or there is not enough time for the ears to rest between exposures). Current guidance suggests loud noise starts at 85-90 decibels (hearing protection needed and time exposure limited).

As a one term guard member, you likely spent 63 days a year, for six years, performing your duties. If you were a Jet Engine Mechanic, for example, that's 378 cumulative days next to decibels that go into the 130s. The chances of experiencing hearing loss or tinnitus are high. A few examples of common military noise exposure:

- 85-95: Forklift operation
- 80-100: Generator running
- 96-110: Musicians rehearsing (looking at you, my Legion Band people)
- 118: Armored Personnel Carrier going 40mph
- 130: Jet takeoff
- 155: 5.56mm Rifle (http://multimedia.3m.com/mws/media/1262312O/3m-noise-navigator.xlsx)

As noted before, if your MOS is not in the high or moderate noise exposure categories, make sure to argue the "other duties as assigned" part of your job. We've all spent time in tents next to noisy generators, spent more than average time at a firing range, and have certainly spent significant time bustling about in a HMMWV. Taking the numbers from above and applying the table below, you can see how many military members often exceed recommended noise limitations:

Quick blurb on tinnitus: I've found a lot of veterans that never truly understood the definition, so here's a good explanation from OSHA: Tinnitus, or "ringing in the ears," can occur after long-term exposure to high sound levels, or sometimes from short-term exposure to very high sound levels, such as gunshots. Many other physical and physiological conditions also cause tinnitus. Regardless of the cause, this condition is actually a disturbance produced by the inner ear and interpreted by the brain as sound. Individuals with tinnitus describe it as a hum, buzz, roar, ring, or whistle, which can be short term or permanent.

My advice, looking at this data? File a claim for hearing loss and tinnitus. The VA will review your Service Treatment Records and send you for an audiology exam. I also highly encourage you (and your service officer) to write a 4138—a statement of what happened that lead to your hearing loss. If everything works out, you'll have your foot in the door of the VA. Worst case scenario? You're out the time of the audiology exam, but in the same boat you're in now. Department Constitution and Bylaws Resolutions Deadline May 7, 2020

The deadline for submission of resolutions calling for the amendment of the Constitution and Bylaws of The American Legion Department of South Dakota is rapidly approaching.

Proposals for amendment to the Constitution and Bylaws must be received in State Headquarters at least (6) six weeks prior to the annual state convention. This requirement is to allow sufficient time for the resolutions to be reviewed by the Department Internal Affairs Commission and to allow sufficient time for the Department Adjutant to forward copies of all recommendations for amendment, along with the recommendation of the Department Internal Affairs Commission to all posts.

The deadline to submit a resolution to amend the Department Constitution and Bylaws to State Headquarters is May 7, 2020.

A resolution consists of two parts: the Preamble (description of the problem)

and the Resolving clause (how the local post, department, or the national organization should solve the problem or support the issue.)

If you or your post are interested in writing a good resolution using the proper format, please refer to page 136 of the 2018 Officer's Guide and Manual of Ceremonies. Every Post Commander and Post Adjutant has a copy of this manual. Remember to submit your resolution through your post. General resolutions are due to State Headquarters two weeks prior to Department Conven-
