Program Purpose

The South Dakota American Legion “*Educator of the Year*” Award program serves to recognize dedicated and devoted individuals who, on a constant basis, give so much of themselves on behalf of the children of South Dakota.....Teachers.

Many programs within South Dakota schools conducted by the South Dakota American Legion and other organizations are designed to recognize and benefit the students of these school systems.

However, no program known recognizes the work performed by teachers, not only in assisting our organizations with these programs but more importantly recognizing the contributions made by teachers on a day-in, day-out basis.

Just like veterans, teachers are the unsung heroes of this nation who build our nation’s future by working with the youth of today.

The Department Americanism Committee believes the presenting of an “*Educator of the Year*” award within the South Dakota American Legion will serve to strengthen the bonds that exist between The American Legion, the schools of South Dakota, and the administrators and educators of these schools.

It is felt this program will increase the recognition factor and exposure of the South Dakota American Legion within the schools of South Dakota and be beneficial to our efforts in South Dakota schools and for South Dakota youth in years to come.



Program Criteria / Structure

1. The South Dakota American Legion "*Educator of the Year*" Award is open to any educator in grades K-12 in any public, private, or parochial school or academy in the state of South Dakota recognized by the South Dakota Department of Education.
2. The South Dakota American Legion "*Educator of the Year*" Award is open to any educator in any course(s) of instruction.
3. The South Dakota American Legion "*Educator of the Year*" Award is open to every Post in the Department of South Dakota.
4. As established by the Department Americanism Committee the levels of award for this program will be:
 - A. Department "*Educator of the Year*"
 - B. District "*Educator of the Year*"
 - C. Post "*Educator of the Year*"
5. The Department "*Educator of the Year*" will be selected by the Department Education Loan Committee from all 8 District winner nominees and will receive a suitable plaque to be presented at a local venue.
8. It is suggested that each District establish a suitable certificate and/or plaque for presentation to the District "*Educator of the Year*" during their Spring District meeting.



South Dakota American Legion Educator of the Year Award

1. Each **Post** shall select a Chairman whose responsibility will be to provide the District Committee with a suitable and qualified nominee for the award (Grades K-12) during American Education Week in November.
2. The Department shall make an official entry form available to each Post. This form will be the **only** method acceptable for Posts to certify the name and accompanying documentation to the District Chairman. Posts will work with their nominee in completing the nomination entry form. The nomination entry form with support of the Post nominee must be forwarded to the District Chairman at least 10 days prior to the Spring District Convention.
3. Each District Commander shall appoint a Committee of not less than three (3) nor more than five (5) members whose responsibility shall be to judge all applications from the Posts in their District and select one (1) who shall represent that District in the Department competition.
4. Each District Chairman shall set his/her deadline for determining the District winner. However, all District winners shall be certified to the Department Headquarters no later than **May 1**.
5. The members of the Department Educational Loan Committee will have the responsibility to judge and select from the 8 District candidates one (1) Department "*Educator of the Year*" winner.
6. All nominees for this award must be living, full-time educators within the State of South Dakota.
7. No Department winner may be certified for consideration of "*Educator of the Year*" for successive years.
8. Membership in The American Legion or having the status of veteran shall not be requirements for consideration in qualifying any nominees for this award.
9. The nomination for this Award of any member who sits on this committee shall not jeopardize that member's position on this committee. The nominee shall enjoy the same privileges and the responsibilities as all other members.
10. Entry forms provided by the Department shall be used as the sole instrument of certifying a nominee and shall not be used as a basis of accumulating points toward determining a winner. Final judgment shall be made from the documenting materials appearing on the 28 pages in the scrapbook album.
11. **The American Legion has designated November as American Education Week. It is proper that we select and honor the outstanding educator in the State of South Dakota.**



**Rules for Determining Department Winner
for
Educator of the Year Award**



1. The District Chairman shall be responsible for the assembly of the District winner's scrapbook album. This may be accomplished by a method of the District Chairman's own choice. *It is suggested that the District Chairman work with the Post from which the selected candidate is from to assemble the scrapbook album.
2. The scrapbook album will be a three-ring binder, 8 ½ x 11 ½ inches. (Labeled & tabbed).
3. The scrapbook album shall contain 8 acetate folders (document protectors) providing 28 sides, front & back, for material to be judged and one acetate folder for the candidate's entry form and one side for the rating form.
4. A photograph of the candidate must be submitted. (Prefer a 4x6 full length or waist up photo of candidate).
5. Numbered tabs (dividers) should be used to separate the album into sections suitable for judging.
6. The deadline for certifying District winners to Department Headquarters is **May 1**.
7. The chairman representing the District from whom the Department winner is selected shall be notified by mail.
8. Final judging at the Department shall be by the members of the Educational Loan Committee in **May**.
9. The Department winner shall be declared on an accumulation of total points using the following rating system:

SECTION I	Professional Career	(0 to 20 Points)
SECTION II	Community Service	(0 to 15 Points)
SECTION III	Family	(0 to 10 Points)
SECTION IV	Letters of Recognition	(0 to 5 Points)
10. It is the responsibility of the District Chairman to assure the presence of the Department winner at the local venue for a presentation.
11. The Chairman representing the Department winner shall be prepared to provide additional biographical data, if necessary, for a suitable presentation.
12. Each Chairman shall commit their District to the certification of a District winner to the Department by the established deadline. If he/she feels that this cannot be accomplished, he/she shall submit his/her appointment resignation to his/her District Commander.
13. It is great to be a District Chairman, but it's even greater to be a successful one by assuring the challenges and responsibilities attendant with that appointment. Yes, you were chosen as a Chairman because of your record, but with the expectation that you would perform successfully. Don't let your District Commander down. **PRODUCE!**
14. The District Chairman should not only give minimized reports at District meetings, but should make personal contacts with various post officials throughout their District thereby encouraging multi-post participation in this outstanding program.
