## Past Department Commander Vernon Sip Reports to Post Everlasting



Vernon J. Sip passed away Wednesday morning, May 10th at his home at Angelhaus in Yankton, SD. Funeral services will be held at the United Methodist Church in Wagner at 11:00 A.M on May 15th. Burial will be in the Presbyterian Cemetery on the Delmont Road east of Wagner with military honors. A visitation will be held from 5-7pm on May 14th at the United Methodist Church in Wagner. Peters Funeral Home of Wagner is in charge of arrangements.

Vernon John Sip was born to John and Myrtle (Nelson) Sip on the family farm on April 21, 1934, the third of four children.

Vernon graduated from Wagner High School in 1952, after which he enlisted in the Army in 1954. He was very proud of his family, service to his country, his National Guard family and his family farm. Vernon was happy to make the rank of Sargent Major and retired after 40 years of service. He continued his love for his country by being an active member of the American Legion. He was elected State Commander for the American Legion in 2001-2002.

Other interests included the American Karate Association where he earned his black belt in 1985 and his social hours at Booms in Wagner and Welton, AZ with friends. Vernon was a welcoming and friendly individual. There was nothing brighter than Vernon's smile and the kindness he brought to everyone he met.

Vernon was married to Judith (Ghyselink) Sip for 40 years and they raised four children: Patricia Auch (Dale)-Magnolia MN, Lisa Schoenfelder (Paul)-Wagner, SD, Lori Cerny-Dorchester, NE and Steven John Sip-deceased. Vernon is also survived by 10 grandchildren, 9 great grandchildren, many beloved nieces and nephews, great-nieces and nephews and great-great nieces and nephews as well as a wealth of friends that Vernon has had over the years.

Preceding him in death were his parents, John and Myrtle Sip, wife Judith, sisters Marcene Blaha and Shirley Eitemiller, brother Burnell Sip, son Steven Sip and grandsons Paul John Auch and Kyle Cerny.

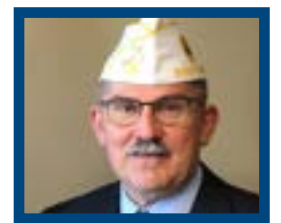

## From the Adjutant

Spring seems to have finally arrived in Watertown. I am still waiting for the trees to get their leaves. Headquarters is working hard to get ready for the Department Convention 8-11 of June. Time seems to have sped up as the event gets closer. This will be my last column as the Department Adjutant. I will be stepping down shortly after the Department Convention. My replacement is the current Director of Boys State, Christopher "Van" Van Delist. We will be starting our turnover about the 22nd of May, and I hope you will show him the same support I was given as I started over three years ago. A few final thoughts for my last column.

Membership. We must find ways to connect with other veterans who are not members. Membership is the backbone of the Legion, at the National level, Department level and Post level. Nationally, the more members the organization has, the more influence we have in Washington and getting veteran centric legislation passed. At the Department level, the same holds true, plus funding for our programs is enhanced. As I write this, South Dakota is about 1,500 below goal for this year. Financially, that means our budget is \$22,500 behind where we had hoped it to be. Our current membership is a little over 15,500. Five years ago, our membership was 19,152

or about 3,600 more than today. At the Post level, membership means people to work on your programs and help the community. Membership is not just the job of the membership committee or the Go Getters. It needs to be an all-hands effort. Just think, if even just half of our members recruited one new member, our membership would be over 23,000 members.

Communities. It is a true fact, those posts that are very active in their communities, not only creates a stronger community, but also have stronger posts. Programs like funeral honors, Flag etiquette classes, school programs, Legion Baseball, Boys state, Legislative programs all help the communities and schools. We know there are some posts that do not have the membership for all programs but do what you can do and do it well.

I have enjoyed working as your Department Adjutant. I have met great Legionnaires and made many friends. The work is certainly rewarding, and I will miss it. I am not leaving the Legion behind, but just stepping back from the Adjutant's position. I will continue to contribute the best I can in other capacities. As a 30 year Navy veteran, I will end with our normal closing, I hope for fair winds and following seas to all.

We listen to many speakers and take action on several resolutions dealing with veterans benefits, veterans health as well as the National Cemeteries. We make a point to provide all the information we can get my hands on from our meetings and make it available to all VA&R Commission members in our department.

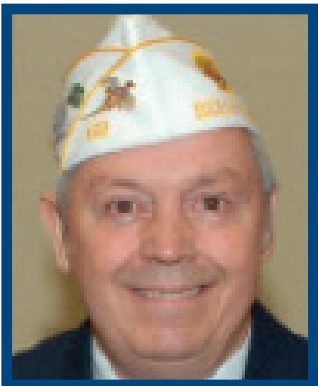

Certificates will be presented to the first, second and third place winners at our State Convention.

I encourage all post historians to put together a post history. Your Post members will appreciate your hard work in the years to come. I thank all Post historians for their hard work and commitment in preparing these reports.

All Post Histories must be turned in by Friday, June 9th by 1 pm at the Registration Desk. If you can get them to me sooner, that would be great.

As an Eagle Scout and Legionnaire, it has been an honor to serve as the chairman of the Department Scouting Committee this past year. Our committee includes Matt Lagerstrom, Christopher Rendon, Richard MacDonald, and myself. Along with Department Adjutant Kevin Hempel, we have three Eagle Scouts and two longtime Scouting supporters on the committee.

Boy Scouts were the first youth group that the American Legion supported. Our support for the Boy Scouts of America began at the American Legion's first national convention in 1919. Nationally the American Legion sponsors 2,500 plus units. South Dakota has two primary Councils: The Sioux Council in the East and the Black Hills Area Council

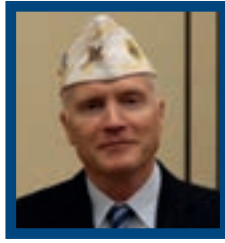

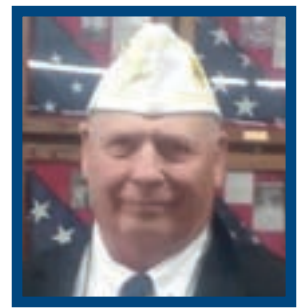

Thank You, State Commander Doug Feltman for the appointment to Chairman of the V.A.V.S. Committee this year. It was challenging at times, but in the end we met the goals we set out for.

We have dedicated leaders in our VA Hospital Representatives: Sioux Falls VA Hospital VAVS Representative Larry Panning; Hot Springs VA Medical Center and State Veterans Home VAVS Representative Angela Koch; and our Ft. Meade VA Medical Center VAVS Representative Buck DeWeese. Additionally, I stopped and visited with Sioux Falls VA hospital on site coordinator, Crista Pick, she gave me a tour of the improvements

made to storage areas and introduced me to one of the volunteers. We discussed the operation and procedures used by her office and I left with the impression the operation was running quite well.

During our annual VAVS meeting, it was decided that coming out of the COVID restrictions and with rising inflation to raise the amount given to each facility from \$1000 to \$1100. These funds are used for our Veteran's daily needs, for outing activities, and for the annual Halloween & Christmas parties at each center. Each VA medical center has similar needs such as dental and personal hygiene supplies. There is always a need for snacks [beef jerky], popcorn and coffee, shoes, clothing, stamps, and phone cards. To meet this need it is best that each facility has the cash funds available to purchase what they need.

Knowing that most Posts send in a donation of \$10 for each of our Veterans final service, I encourage that with the recent increase of the funeral stipend from \$50 to \$100 that Posts increase that donation to \$20 or more. Helping support VAVS is just another way The American Legion continues to take care of our Veterans. It is a welcome reminder to our Veterans in Michael J. Fitzmaurice State Veterans Nursing Home and VA Hospitals that "You Are Not Forgotten".

In closing I want to say "Thank You" to all the VAVS. Committee members for their dedicated work for Veterans. "Thank You" to all the Legion Posts, Auxiliaries, Sons of American Legion Squadrons and the American Legion Rider Chapters for your time and monies that go for a great cause, the Veterans! ## Annual Report of the Children & Youth Chairman

The South Dakota American Legion C&Y (Children and Youth) program this past year was a quiet one but a rewarding one. Thank you for selecting me as the Children and Youth Chairman for the Department of South Dakota. Your leadership and willingness to direct my efforts for the year were greatly appreciated.

In the past several years, the C&Y program within SD has worked closely with the Dollar Tree Program, in association with Operation Homefront. This last year, the South Dakota National Guard, took the primary lead on collecting and distributing donations of school supplies for helping those young Veterans families with children at home. The same process was repeated in early December as the Dollar Tree once again collected donations of small toys for distribution to Veterans families. There were a few Dollar Tree stores that did not have a National Guard Armory associated to it to make the donation pickups so local Legion Posts were able to pick up those donations and distribute them within their local communities. In December, with the help of the Brookings and Sisseton Posts, I was also able to pick up donations from 2 other Dollar trees, package gifts into 20 gift bags, and deliver them to the VA in Sioux Falls for distribution to Veterans with children. This is a great program that I hope the American Legion will continue to be a part of.

Additionally, Operation Homefront donated backpacks full of school supplies to Air Force personnel with children at Ellsworth AFB. Around 15 Legion, Auxiliary, SAL and Legion Rider members from Districts one and two, on short notice, volunteered to help distribute 340 of these backpacks on July 30th. It was great to see so many step up to help make this event such a success.

Operation Homefront will continue to offer the school supply, backpack, and toy programs in the coming years. On a side note, through my interaction with Operation Homefront with the Backpack distribution and Dollar tree programs, I have been asked to become a member of the Operation Homefront Advisory Council, to represent the State of South Dakota in the upper Midwest region. I hope to continue to work with future C&Y Chairman of the American Legion, Department of South Dakota, on many more collaboration projects together between the two organizations.

A program that I wanted to promote this year as the C&Y Chairman was a donation fund raiser with proceeds to be split between the Children's Miracle Network (CMN) of South Dakota and youth programs in the South Dakota American Legion, which includes TFA.

Children's Miracle Network helps South Dakota families with sick or injured children with:

- Specialized equipment needs for the Sanford Children's Hospital
- Child Life Specialists to help teach our children about their illness
- Travel assistance, Food Vouchers, Lodging

Veterans with children at home can file for TFA (Temporary Financial Assistance), in times of need to help cover some the immediate needs of the Veterans family. Veterans can apply for assistance through their local American Legion Post.

Early in the year, there was a request to use the TFA program, however at the time, the criteria for using the program were not met because of the situation at the time. Unknow to me, there was an update to eligibility for TFA in the past year that could have been explored. The American Legion passed Resolution No. 5 (May 2022) Titled: Policy and Procedures of the Temporary Financial Assistance Grant Program. The policy clearly states that the minor child must be living full-time in the home of a qualifying veteran or service member. The minor child qualifies if they fall into one of the below categories. Yes, the veteran (grandparent) could qualify for TFA if the minor child(ren) is living in the veteran's home full-time and is under the veteran's legal guardianship or has been adopted by the veteran.

The child is:

- a biological child of the veteran or service member.
- a child legally adopted by the veteran or service member,
- a stepchild by marriage of the veteran or service member
- a child who is under the legal guardian ship of a veteran or service member.

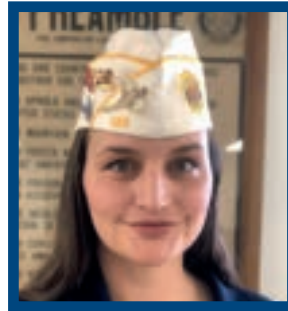

## Annual Report of Department Service Office

I would like to thank Commander Doug Feltman for appointing me to serve as Department Service Officer for 2022-2023.

As Department Service Officer, I have the unique privilege of directly serving Veterans and their families in helping them obtain and utilize the benefits they have earned through service to our country. The VA is undoubtedly its own mountain to climb, and I am happy to be a guide of sorts.

It has been a big year for benefits in the VA world. In August 2022 the PACT Act was passed, a sweeping piece of legislation that covers multiple generations of Veterans. For Gulf War-era and Post 9/11 Veterans who served in the Middle East or the airspace above, the following cancers and illnesses are now presumptive: Brain cancer, Gastrointestinal cancer of any type, Glioblastoma, Head cancer of any type, Kidney cancer, Lymphatic cancer of any type, Lymphoma of any type, Melanoma, Neck cancer of any type, Pancreatic cancer, Reproductive cancer of any type, Respiratory (breathing-related) cancer of any type, Asthma that was diagnosed after service, Chronic bronchitis, Chronic obstructive pulmonary disease (COPD), Chronic rhinitis, Chronic sinusitis, Constrictive bronchiolitis or obliterative bronchiolitis, Emphysema, Granulomatous disease, Interstitial lung disease (ILD), Pleuritis, Pulmonary fibrosis, and Sarcoidosis.

For Vietnam Veterans, the presumptive list for Agent Orange exposure now includes MGUS (blood disease) and Hypertension. Additionally, the PACT Act expanded the presumptive locations to include Any U.S. or Royal Thai military base in Thailand from January 9, 1962, through June 30, 1976; Laos from December 1, 1965, through September 30, 1969; Cambodia at Mimot or Krek, Kampong Cham Province from April 16, 1969, through April 30, 1969; Guam or American Samoa or in the territorial waters off of Guam or American Samoa from January 9, 1962, through July 30, 1980; and Johnston Atoll or on a ship that called at Johnston Atoll from January 1, 1972, through September 30, 1977.

On January 17, 2023, funding starting for the COMPACT Act, a bill that passed in 2020 that allows Veterans in suicidal crisis to go to any health care facility, at VA or in the community, for free emergency health care regardless of their enrollment in the VA system. This is a huge benefit and will help in our fight against Veteran Suicide.

I am thrilled to report that State, County and Tribal Veterans Service Officers around South Dakota utilizing the American Legion Power of Attorney have secured \$42,545,265 in VA benefits for South Dakota Veterans and their families in Fiscal Year 2022. If you have not thanked your local Veterans Service Officer lately, please do so!

2022/23 was a lackluster period for the Educational Scholarship Committee. In 2019, we changed from a loan concept to a scholarship format investing \$120,000.00 with the South Dakota Community Foundation.

Our beginning fund balance (1/1/2022) was \$145,496.84 and ending fund balance (12/31/2022) was \$123,309.68. A loss of \$22,187.16. In the account at State HQ, we have \$20,239.51. We received zero donations in 2022. Five applications were received for this year's scholarships. Recipients will be announced in an upcoming Up To Now. Applications and brochures are online at [www.SDlegion.org](http://www.SDlegion.org). We are currently revising the application for 2023/24 scholarship year.

The 2023 Educator of the Year packets were due May 1, 2023. Because the deadline for this article was April 28, 2023, the committee did not have time to review the packets. The winner will be announced at the state convention and Up To Now.

The education scholarships offered by the Department of South Dakota are for children of veterans, grandchildren of veterans, and veterans who meet the requirements as set forth in the Education Scholarship brochure attending post-secondary education, college, or technical schools. Please read the brochure for all the current changes. In all cases, the veteran listed on the application must be a member of the South Dakota The American Legion. The student must attend a higher education school in the state of South Dakota unless their plan of study is not taught in a South Dakota school. The fund is self-sustaining through donations.

Annually, the brochure and application processes are reviewed. No monies were added to the fund from the Department's outside income programs. More specific details can be obtained from State Headquarters, your District Education Loan Chairperson, or a member of the state Education Scholarship Committee. The state committee consists of Michael Pauling, Piedmont, Philip Egeberg, Brookings, and Hugh Holmes, Mitchell.

Mr. Commander, thank you for selecting me as chairman of the prestigious Education Scholarship Committee. It is a great honor. Charlie Brown did win one game in his cartoon career!

## Annual Report of the Sons of American Legion

This year for the Sons of The American Legion – Detachment of SD has been nothing shy of amazing. After the year we had last year, I knew this year would have its work cut out. The Sons across the state have stepped up and proven they are always up for a challenge. The year was started off by attending the National Convention in Milwaukee Wisconsin. The SD detachment was well represented and brought home an astonishing 11 National awards. These awards included the Triple Nickel Award, Arthur D. Houghton Award, and South Dakota is home to the 2021-2022 National Recruiter of the Year, just to name a few. To put things in perspective, a detachment averages two awards at the National Convention, and we had 11 last year. To say South

Dakota is “on the map” at the national level is an understatement.

Coming back from the National Convention, we worked side by side our other family organizations at the South Dakota State Fair in the Veterans Building. This proved very fruitful as throughout the week each organization recruited numerous members and answered questions that were brought forth. Then we went into Fall meetings where we had an officer at each meeting. We believe having a strong presence at events creates a caring, important impression for the SAL.

## National Commander Memorial Day Message

Dear American Legion Family and friends,

A commonly used phrase in The American Legion is “every day is Veterans Day.” We prove this through our programs and service to our communities. But for Gold Star families and the battle buddies of the fallen, every day is Memorial Day.

When American servicemembers are seriously wounded, often their last words are some variations of “tell my wife I love her,” “tell my kids I’m proud of them,” or “take care of my family.” The parents of fallen heroes live every mother’s and father’s nightmare, burying their child.

Marine Corps veteran Rosanna Powers understands the meaning of sacrifice. She lost her brother, Lance Cpl. Caleb Powers, as he served in Iraq on Aug. 17, 2004. The very next day, her fiancé, Marine Sgt. Richard Lord, also made the supreme sacrifice there.

“We can debate the war’s legacy and what it means for the future of American foreign policy. But remember who stands ready to protect our freedom to have those debates and remember those who died to keep that freedom safe,” Rosanna wrote in a Fox News commentary. “It’s up to us to honor them, in our own way, by trying to make the country they died for a better place.”

When politicians debate the cost of veterans benefits, we should remember the price already paid by fallen servicemembers and their families. This is the true cost of war.

There is also the cost paid by some who served outside the officially recognized war zones. More than 1,600 Americans have lost their lives fighting in covert operations and cold war battles that have occurred since the attack on Pearl Harbor.

Danger is inherent with all military service. This spring, nine young soldiers with the 101st Airborne Division lost their lives when two Black Hawk helicopters crashed near Fort Campbell, Ky. They trained in defense of our freedom.

While Memorial Day is a time of remembrance, we can also celebrate the lives of the more than one million men and women who loved this country enough to die for it. For that, we should always be grateful.

## Annual Report of the American Legion Riders

Serving as the Department Commander's "American Legion Riders Liaison" has been an honor this past year. The American Legion Riders are one of the most visible and popular programs of the American Legion. The chapters of the American Legion Riders' strength come from their efforts at the post level, where its members manage the chapters. The uniqueness of this program resides in its membership, which includes Legionnaires, Auxiliary, and Sons of the American Legion.

The American Legion Riders guide their activities around the American Legion Four Pillars: Veterans Affairs and Rehabilitation; National Security, Americanism, and Children & Youth.

Chapters support the first pillar, Veterans Affairs and Rehabilitation. The Chapters provide final respects to Veterans with escorts and flag lines at funeral homes, churches, and cemeteries, many at the Black Hills National Cemetery. Chapters reported participating in homecoming parades, parades of lights, Fourth of July, and city parades. Four times a year at the Black Hills National Cemetery, American Legion Riders join other veteran organizations and supporters in helping to provide unaccompanied veterans an honorable service.

Chapters supported veterans in VA facilities through programs such as Christmas in July, National Salute to Veterans Week, Veterans' Day, the Four Chaplains Memorial Service, Valentine's Day, Christmas Gift Shop, parties, bingo, and ice cream socials, to name a few.

Chapters support Veterans in the community by conducting Veterans Day programs, a poker run for Suicide Awareness, socials and picnics, decorating veterans' graves for Memorial Day, placing Holiday Remembrance Wreaths and helping with Wreath Across America at the Black Hills National Cemetery and State Veterans Cemetery in Sioux Falls. The Riders also help preparing the "Avenue of Flags" at the Black Hills National Cemetery. In addition, they lead the Black Hills State University Jacket Ride that raises funds for veterans' scholarships.

To support the second pillar, National Security, one of the main focuses is to promote full accountability of the POW/MIAs through community and youth awareness. The chapters reported performing several POW/MIA Ceremonies of Remembrance at conventions, dinners, and schools. Riders also support the troops by providing escorts, flag lines, and sending care packages. Riders assisted with the "We've Got Your Six Veterans Appreciation Fair" in the Northern Black Hills. This year, the Black Hills Riders Chapter #164 planned and held the Colonel Mike Kain Memorial Blood Drive which surpassed its goal.

Americanism is the third pillar. Two main events and programs highlight the impact of the riders. The first step is to educate our youth, resulting in Flag Protection awareness. An annual flag etiquette program by Black Hills Chapter #164 touched 180 first graders in Spearfish; 140 kindergarteners in Belle Fourche, and 30 preschoolers in Sturgis. All chapters reported, planned, and organized poker runs to raise funds for the signature program of the American Legion Riders.

As for the fourth pillar, Children & Youth, the American Legion Riders are known in many communities for their volunteerism and service. Some of the most common and regular activities are fish fries, bingo, color guards at community functions, and visiting veterans in hospitals and residential facilities. Other community-based projects are annual events such as sponsoring bands in the park free of charge to the public, participating in community chili cook-offs to support adults with disabilities, and posting colors at the Relay for Life event. Rapid City Chapter #22 adopted a first-grade classroom in Sturgis and conducted monthly activities with the students. Rieck-Morgan Warner Chapter #137 holds a Teddy Bear Ride to collect plush bears to distribute to children while going to hospitals in the Aberdeen area. The Ft. Pierre Chapter #20 held their first fundraiser to support Sleep Heavenly Peace to build beds.

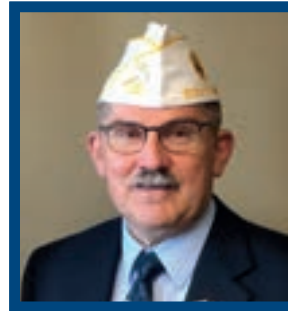
The Riders come together to support their community, the veterans, and military service members, sharing a common love of motorcycles. The American Legion Riders is growing in membership and chapters; this past year, Ft. Pierre Post 20 started a Chapter, bringing our total to 13 chapters.

The year is really going fast and I'm enjoying being your National Executive Committeeman. At the Spring District Meetings this year, I've been discussing the issues that The American Legion has put forth as their priorities for the upcoming year. At the American Legion Legislative Conference in Washington D.C., we discussed the issues and Legionnaires from all over the country went to Capitol Hill Tuesday and discussed these issues with their congressional delegation. Wednesday morning, I had the honor of attending the National Commander's testimony before the joint Senate and House Veterans Affairs Committee. The National Commander did an excellent job

representing The American Legion. The legislative priorities for the upcoming year are Mental Health & Suicide Prevention, VA Healthcare Modernization, Implementation and Oversight of the Pact Act, Protect Veterans from Predatory Actors, Concurrent Receipt, Guard and Reserve GI Bill Parity, GI Bill for Honorable Service, support our Afghan Allies, Military Quality of Life, Pay the Coast Guard and Protect the American Flag.

The National Commander's program this year is the Veterans & Children Foundation. This foundation is used to fund the training for over 3,000 American Legion Service Officers. The American Legion service officers secured an estimated \$14.25 billion in disability compensation and other benefits to veterans in 2020 alone. Also, funds are used for the temporary financial assistance program for veterans that are in need that have minor children at home. Funds from this fund have come into South Dakota to help veterans in our state who really needed help. The goal for South Dakota is \$30,728.26. To build this endowed fund up, all departments were asked to give 25 cents a year per member for six years or \$1.50. We have a little over 2 years left to make our goal and presently we are a little over halfway there. Please, if your Post is able, give a dollar per member to this fund. Send your Post donation to State Headquarters, National Headquarters, or the National Commander when he comes into the state.

Don't forget the Buddy Check Program. "Be the One" to prevent a veteran from committing suicide. I would like to close by saying thank you and your post for all you do for the American Legion. No matter how big or small, anything you do makes a difference.

On January 24, 2023, the committee held a Zoom meeting to review bills and discuss those of concern to The American Legion Department of South Dakota. The priorities were set, and the committee agreed on which bills we were going to watch, lobby for and lobby against.

The Legislative Committee met in person on February 7, 2023, at Post 8 to review the session up to that time and adjust priorities as necessary. Roll call showed the following committee members present: Department Commander Doug Feltman, Department Adjutant Kevin Hempel, Chairman C.P. Van Delist Mike Mehlhaff and Kevin Morello. That evening Post 8 hosted a Legislative reception with all Legislators invited. This reception gave all in attendance an opportunity to discuss legislative items and issues that impact on Veterans. Special thank you to Post 8, as always, they were an amazing host.

Below are the results of the bills on the Legislative Committee's list:

HB 1039 to revise certain provisions regarding the payment of tuition for members of the South Dakota National Guard. Signed by the Governor on Thursday, March 16, 2023

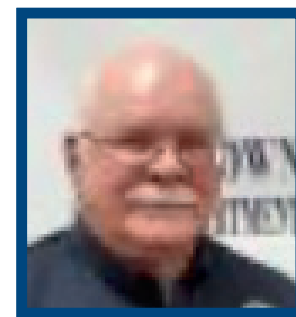

## Annual Report of the Foundation

Your South Dakota American Legion Foundation began in 2010, because of the foresight of our leaders at the time, in believing that it is important to have a steady source of revenue to help support the many valuable programs of the American Legion. It is structured as a 501(C)(3) non-profit corporation, so that the donations to it can be tax deductible for the donor. The funds are professionally managed by the South Dakota Community Foundation. As they accumulate, the donations to the Foundation go into an endowed fund that is invested. It is the return on these investments that becomes available to the SD American Legion to support the programs. In this way, the endowed fund itself is not depleted, and the returns on the investments will continue forever.

The Foundation works! The present balance is approximately \$275,000. Approximately \$10,000 per year is available back to the Legion for its programs. In recent years, Grants have been made to the following: The SD American Legion's Children and Youth program; SD Boys State; Midwest Honor Flight; The SD American Legion's Youth Trooper Academy program; and The National Veterans and Children's Fund. At the present time, funds are available for more granting.

Donations can be in many forms such as: outright gifts of cash or property; bequests through your estate by naming the SD AL Foundation in your will; memorials in memory of friends and fellow veterans and Legion members who have passed on so that their legacy will continue to live forever; naming the SD AL Foundation as the beneficiary of a life insurance policy so it will pay out upon your death; as an IRS approved "IRA Charitable Rollover Gift" so that your distribution is paid directly to the Foundation, rather than become taxable income to you. All of these gifts help assure that the American Legion programs that you care about will continue to be supported forever. Gifts of \$10,000 or more by an individual, entitle the donor to name the specific Legion program that he/she wishes to support. Please let the Foundation know if you would like assistance in structuring a donation.

Thank you to all of the individuals, Legion Posts, veterans' organizations (within and outside of the Legion Family) and businesses who have made donations to the Foundation! Many Posts and individuals regularly give memorials to honor friends, fellow veterans and Legion members who have passed on. If your Post is one of those, thank you very much! ## Annual Report of the Americanism Chairman

I have enjoyed the opportunity to serve as your South Dakota American Legion Americanism Chairman. I attended the National Americanism Conference in Indianapolis in September. State representatives shared their successes and concerns.

The American Legion Scholarship Program – An Oratorical contest (open to students grades 9 thru 12 enrolled in public, parochial, military, private or state accredited home school) started at the Post level in December. High school students throughout the state prepared speeches based on the United States of America Constitution in a friendly cordial competition. Thank you also to the members of the Americanism Commission, District Americanism Chairmen and the entire American Legion family helping. The assistance of well-versed Legionnaires is always helpful.

Five Districts were represented in the Department Oratorical Contest. Thank you Huron American Legion Post and District #6 for coordinating most of the personnel needs for the Department finals at Crossroads on February 12th during the Midwinter Conference. Some schools do not include the American Legion Oratorical program in their curriculum. I encourage Legionnaires in those to look to individuals or organizations to sponsor a local contest. ## Annual Report of the Athletic Commission

My report begins with the start of the 2023 baseball season. Jan 1st begins the start of a new baseball season with all teams completing registration by May 15th. Hopefully we will have another successful season as we did last year with a record number of teams being registered in 2022.

Tournament sites for 2023 are as follows: State A Sr Tournament to be held in Yankton from July 25th thru July 29th; St B Sr Tournament to be held in Redfield from July 28th thru Aug 1st; St A Jr Tournament to be held in Harrisburg from July 27th thru July 30th and the St B Jr Tournament to be held in Lennox from Aug 4th thru Aug 6th. This year's Golf Tournament will be hosted by Hermosa at 2 different locations in the Rapid City area. Everything is all arranged and looks to be on schedule.

On Jan 29th of this year we made selections for the 2024 tournament host sites. They are as follows: St A Sr will be hosted in Mitchell; St B Sr will be hosted in Salem; St A Jr will be hosted in Pierre and the St B Jr will be hosted in Groton. No selection for the Golf tournament yet for next year. If interested in hosting Golf please contact Elton Blemaster or Gene Gillen.

Just a note on hosting any of our tournaments. We need our Posts to get involved with our parent groups when hosting any of our tournaments. Last year we had 2 tournament sites that the Posts would not sign contracts for hosting the tournaments. Reasons for not signing were, did not know we were hosting a tournament, worried about insurance liabilities or worried about their financial obligations. To address some of concerns are that when a team purchases their teams insurance a 2 million liability is included with your team's accidental insurance, that should cover any issues that might occur. As far

as financial concerns, in my 20 years of running this program a post has never lost a dime, in fact last year one of the Posts not wanting to sign a contract lost out on a percentage of a \$13,000 net gate that the parent group took in and I think would have been willing to share with post at some percentage with a little support. Please get involved or get your Sons of A.L. involved if you have one, if not this would be a great reason to get one started.

What's new for 2023? We were supposedly changing our branding label, which meant new uniform patch or logos. We were supposedly getting new baseball patches for all our uniforms that would have been required by 2024. But that has again changed because of the limited supply of the new patches available. So for teams purchasing new uniforms this year you will once again be required to use our already existing patch until further notice. I think will solve our current Branding issue until further notice and further research can be completed.

One more thing to bring up is that the SDHSAA is considering sanctioning baseball as a High School sport. As of now nothing confirmed yet but it is coming. My only concern is that we don't want them to extend that season into June. That would totally ruin our season and program. Currently their tournaments end on Memorial Day weekend which works great with our program and I do support. For years they have done it that way and it has been working just fine. I think they are maybe pushing for a bit longer season as I also would have liked to start our season in May instead of June like we currently do. I am scheduled to meet with the SDHSAA after the Basketball season. Please let your AD know that we support their program but it cannot go into June for their tournament play. Thank You!
