NATIONAL DUES INCREASE!

At the 2023 National Convention, a \$5 dues increase was passed that will take effect July 1, 2024. This increase will require all Posts to charge more for membership and makes submitting <u>Post</u> <u>Data Reports</u> critical this year. More information to follow.

UP COMING REQUIRED REPORTS

The following reports or inputs will soon be due. Please take the required actions as needed:

- 1. <u>Post Data Report (PDR).</u> With the National dues increase the PDR is critical this year. This report was mailed to Posts in February. The PDR identifies the dues amount for the post as well as the mailing address for the dues and post. At a minimum member dues should be \$38.50 or the Post will have to make up the difference. PDRs are due to HQ by **April 15.**
- Post Americanism Report. This form reflects what the Post has accomplished for Americanism programs. It is used to select the Golden Eagle award for excellence in Americanism programs. This report can be found in the Department's Post Adjutant's Administrative and Awards Manual, page 18, and is due to HQ May 1st.
- 3. <u>Post Officer Certification.</u> This form is found in the Department's Post Adjutant's Administrative and Awards Manual, page 27, and is to be submitted to HQ in after the Post officers have been sworn in for the next year.
- 4. <u>Consolidated Post Report (CPR)</u>. The CPR is the Post's method to report what has been accomplished for the year. The data is used by the Department and National Headquarters to report on activities of The American Legion. The form will be included in this Up To Now or can be found on the Department website. It is also available on line on the National website and is due June 1st.

2024 SOUTH DAKOTA LEGISLATIVE UPDATE

The SDAL Legislative Committee met Jan 22, 2024 to discuss the SD Legislative Session and Bills in the que for this session. The following was the outcome of this year's session.

Support:

HB 1008 modify the eligibility for admission to the state veterans' home and repeal the residency requirement. Signed by the Governor on February 27, 2024

HB 1067 designate Medal of Honor Recognition Day. Signed by the Governor on 2/21/24

HB 1082 (Amended) change the eligibility requirements, and the exempt value, of a property tax relief program for disabled veterans and surviving spouses. Delivered to the Governor on 2/27/24

HB 1101 provide a special motor vehicle license plate for recipients of the Legion of Merit award. Signed by the Governor 2/12/24 HCR 6007 Encouraging the United States Congress to allow veterans to receive long-term care services at facilities that do not otherwise meet the requirements set by the United States Department of Veterans Affairs. Enrolled 2/20/24

SB 29 allow eligible members of the South Dakota National Guard attending an in-state private, nonprofit post-secondary institution to receive the state tuition benefit. Awaiting Governor signature

SB 30 prohibit discrimination based on military status. Withdrawn SB 148 provide permissive authority to a governing body of a municipality or county to deny reissuance of an on-sale license not actively used. Delivered to the Governor on 2/29/24

SB 162 make an appropriation for the erection of the South Dakota Sioux Code Talker Memorial and to declare an emergency. Tabled

SB 180 modify provisions pertaining to unethical conduct and improper collection of fees relating to assistance or referrals in a veterans benefits matter. Tabled

SC 803 Honoring the outstanding military service of Major General Michael L. Place. Enrolled

Monitor:

HB 1007 amend the requirement to employ a county veterans' service officer. Signed by the Governor on 2/27/24

HB 1068 allow disabled veterans to obtain a standard issue county motor vehicle or motorcycle license plate. Signed by the Governor on 2/5/24

HB 1121 make an appropriation to provide a grant for the construction of a veteran's skilled trade center. Deferred to the 41st day

HB 1138 establish a sales tax exemption for certain disabled veterans. Deferred to the 41st day

SB 105 provide for the employment of veterans' service officers by the Department of Veterans Affairs. Deferred to the 41st day

STATE ORATORICAL CONTEST WINNERS

Congratulations to the Department Oratorical Winners!

Elena Andrews, Beresford – 1st place trophy and \$1500; Annelise Carley, Rapid City – 2nd place trophy and \$1000; and Aspen Kline, Aberdeen - 3rd place trophy and \$500.

Elena will also receive a plaque to be displayed in her high school's trophy case as the first-place winner of the state contest. She will have the opportunity to represent The South Dakota American Legion at the National Contest, to be held May 17-19, 2024 in Hillsdale, MI. Elena will receive an additional \$2,000 scholarship for participating in the first round of competition at the national level and an additional \$2,000 if she advances to the second round of national competition but does not make it into the final round. Scholarship awards possible in the national level competition are \$25,000 for first place, \$22,500 for second place, and \$20,000 for third place.

BOYS STATE NUMBERS ARE DOWN!!!

Last year was the smallest South Dakota Boys State since it's founding with less than 170 Boys in attendance. There is no limit to how many Boys a Post or school can send. YOUTH TROOPER REGISTRATION IS OPEN

South Dakota Youth Trooper Academy (YTA) runs June 24 – 28, 2024. YTA is an intensive, one week, residential learning experience for young adults who are entering their senior year of high school or have just graduated high school in 2024. YTA is held at the South Dakota Law Enforcement Training Academy in Pierre. The program is mentally and physically demanding. Candidates should be highly motivated, of good moral and ethical character, and have an interest in a career in law enforcement. Space in the program is limited to 24 students from across the state.

THE AMERICAN LEGION LEGACY SCHOLARSHIP

This needs-based scholarship is designed to fulfill a financial gap remaining after all federal and state educational grants/scholarships available to an eligible applicant have been utilized. Children of post-9/11 veterans having been assigned a combined disability rating of 50 percent or greater or who died while on active duty on or after Sept. 11, 2001 are eligible. All applications new or renewal must be submitted using the online scholarship submission system **NO LATER THAN Wednesday, April 10, 2024.**

REMINDER TO ALL AMERICAN LEGION POSTS TO FILE IRS FORM 990

Federal tax regulations require every Post to file IRS form 990. This must be filled out by the 15th day of the fifth month after the end of your organizations accounting period. If the IRS does not receive this form, they will revoke the tax-exempt status of the Post. To get your Tax-exempt status back you have to apply and pay a sizeable fee. This process takes time (months) and can challenge even the most patient of individuals. The form can be downloaded at https://www.irs.gov/pub/irs-pdf/f990.pdf.

NATIONAL COMMANDER MEMBERSHIP INCENTIVE

Commander Seehafer will award a "Be the One" pin to any Legionnaire who obtains two new members, one to replace you and one for growth.

A new member is any person joining for the 2024 year who was not a member in the 2023 year. Transfers do not count.

Only one pin will be awarded per individual. Upon receipt, national membership staff will confirm the names in the national database and mail the pin directly to the person who earned it.

103 PERCENT MEMBERSHIP AWARD

National Commander Seehafer will award his "Be the One" pin to

any post, district, county, and/or Dept commander and membership chair who achieves 103% of their membership goal for 2024.

NATIONAL COMMANDER POST EXCELLENCE AWARD

To qualify, a post must achieve excellence in four areas: membership, submit a the Consolidated Post Report (CPR), attain a 90% renewal rate, and community activity. The standard is as follows:

Membership: Attain at least 103% of their membership goal. At least one post officer attends district meetings.

Consolidated Post Report: CPR submitted by July 1.

90% Renewal Rate: Renew at least 90% of their 2023 members.

Community Activity: The post must conduct an event that connects the local community with The American Legion. The objective is to open your doors, welcome the community in, and educate them on what The American Legion is all about and how the post is an asset to the community.

Certification for the award: The district commander responsible for the post will certify a post as having achieved the four specified criteria. The district commander will submit a list of posts meeting the criteria to Dept HQ. List should include the post name, phone number, address and commander's name. If possible, provide with copies of press releases submitted to the local media about the projects to show that the projects were to enhance the image of The American Legion through local media. Dept HQ will forward to National Headquarters.

100% AMERICAN LEGION FAMILY RIBBON

American Legion National Commander Seehafer will award his 100% American Legion Family Ribbon to any American Legion Family that achieves 100% membership by the 2024 100% membership target date. For this award, the Legion Family is defined as a post and/or any combination of an Auxiliary unit or Sons squadron. Each must achieve 100% membership to qualify for the award. The Dept HQ will forward to National Headquarters.

VA HEALTH CARE EXPANSION

The VA has announced that all veterans who were exposed to toxins and other hazards while serving in the military – at home or abroad – will be eligible to enroll directly in VA health care beginning March 5, 2024. All veterans who served in the Vietnam War, the Gulf War, Iraq, Afghanistan, the Global War on Terror, or any other combat zone after 9/11 will be eligible to enroll directly in VA health care without first applying for VA benefits. Additionally, veterans who never deployed but were exposed to toxins or hazards while training or on active duty will also be eligible to enroll.

SD DEPT OF VETERAN AFFAIRS RESOURCE BOOK

The South Dakota Department of Veteran Affairs (SDDVA)has developed a resource book to educate veterans on the benefits and resources that are available to them and their family. There are many Posts, Units, and Squadrons surrounding Ellsworth AFB that have been able to come and help with the yearly backpack distribution program, which is sponsored by Operation Homefront (OH). This event is held at many military bases during the last weekend in July every year. Operation Homefront also distributes school supplies and toys collected from the Dollar Tree every year. Both of these programs take financial donations, volunteers, and coordination to ensure successful events. There will be more information to come on these two programs in the April newsletter.

In addition to these two highly successful programs, there are also temporary assistance programs, spouse appreciation and support programs, and scholarships opportunities for children of our activeduty and National Guard service members that are or have been deployed on Title 10 orders. See the requirements and types of assistant available below.

Critical Financial Assistance – Eligibility

Documents Required:

Copy of deployment orders for enlisted, title 10 orders for National Guard, documentation of all household income, line of duty documentation or other official record of a wound, illness, or injury being sustained in the line of duty.

Typical use of Financial Assistance:

Auto Payment, Auto Repair, Child and Dependent Care, Critical Baby Items, Dental, Essential Home Items, Food Assistance, Home Repairs*, Medical, Moving and Relocation, Rent and Mortgage, Travel and Transportation, Utilities, Vision Care, Other.

I am sure you will agree that helping our young service members in times of need can be a game changer during desperate times. Many of us can recall how difficult life can be in times of need, as we have been there. Your time and consideration to volunteer or support Operation Homefront is appreciated.
